Special Treasures Fund

REQUIREMENTS FOR APPLICATION

Prior to applying for the AGCI Special Treasures fund, adoptive families must meet the following requirements:

1. Must have an approved application for the AGCI China program

REQUIREMENTS FOR RELEASING FUNDS

Prior to releasing funds, adoptive families must meet the following requirements:

1. Must be a current, contracted client with AGCI
2. Must have an accepted special focus referral through an AGCI partner orphanage in the China program
3. Must have a current home study, approved by AGCI

USE OF FUNDS

Special Treasures funds are not available for expense reimbursement, travel or any other third party and miscellaneous expenditure related to the adoption process. Special Treasures funds are only applicable toward AGCI fees after CCCWA placement approval.

THANK YOU LETTERS

Our donors, board of directors and dedicated staff work very hard to provide families with grants. We ask that, both at the time of the award and at six months post-adoption, families submit a thank you letter for AGCI to share with our supporters.
